Investment Objective 投資目標

The Haitong Low Carbon Pioneer Equity Fund will invest primarily (i.e. at least 70% of its Net Asset Value) in a portfolio of China A-Shares and equities of companies listed on the Stock Exchange of Hong Kong,
1) to achieve long-term capital growth; and

2) to achieve an overall improvement in the carbon emission intensity level at the Sub-Fund's portfolio level as compared to the Screened Investment Universe (as defined below), by maintaining the weighted average carbon emission intensity of the investments in the Sub-Fund's portfolio (which is weighted by the value of the Sub-Fund's holding in each company) at least 20% lower than the market capitalisation-weighted average carbon emission intensity of all companies in the Screened Investment Universe, Carbon emission intensity data measures the amount of carbon dioxide equivalent (in metric tonnes) emitted per billions of sales (mt/bil), which are periodically disclosed by listed companies.


